Eligibility and qualification of the Applicant will be first examined based on the details submitted under first envelope (PQQ / Technical) with respect to eligibility and qualification criteria prescribed in this Tender document. The BQQ / Commercial bid under the second envelope shall be opened for only those Applicants whose PQQ / Technical Applications are responsive to eligibility and qualifications requirements as per Tender document.

- **Earnest Money:** The party will deposit the earnest money (mentioned above in table) by RTGS/NEFT before expiry date. The tender will not be accepted without earnest money. EMD will be refunded in case no order has been placed. In case an order has been placed then EMD will be refunded after delivery of material / completion of Jobs.

- **Security Money:** - The party will have to be deposited security within a week from the date of issue of work order. The security will be forfeited if the work is found unsatisfactory or the contractor fails to execute the work during the period of agreement. Amount of security money will be decided at the time of negotiation.

#### Terms & Conditions for contractual jobs:-

1. The Contractor will provide 2 Nos. of Tractors with pusher and one Loader.
2. Diesel cost and manpower are in contractor's scope. No extra payment will be made for diesel, other consumable & manpower.
3. In each shift 2 nos. of manpower will be compulsorily supplied by you for continuous bagasse feeding. Cleaning in BC-1 tunnel will be done by your labour.
4. Minimum 40 Ton per hour bagasse shall be fed during shut down of sugar mill.
5. The accommodation will be provided for your workers near fuel yard, as per availability in our premises.
6. The contractor will provide substitute vehicle immediately, in case any operational vehicle break down or goes for repair and maintenance.
7. The contractor will provide a supervisor in each shift to supervise your work/machinery, and they will report to the power plant Head.
8. Minimum 3 (Three) Tractor drivers are required to be present in each shift for (02 tractor & 01 dozar).
9. In case plant is not in operation for more than two days, payment shall not be made for the non operational period.
10. In case vehicle (tractors) is used during the non operational period, payment shall be made @Rs. 4000/- per vehicle per 24 hours.

11. Facility of minor welding work and compressor air will be provided to you by NSML but you shall arrange for major maintenance on your own.
12. If Turbine trips due to improper feeding of fuel, Rs. 10,000/- penalty will be imposed on daily basis and same will be deducted from your bill.
13. The contractor will take up the jobs immediately and ensure the satisfactory completion as per the instructions of power plant Head. If your progress remains poor, then this work will be got done at your risk & cost and no correspondence will be entertained.
14. If the work of contractor is not satisfactory, the contract is liable to be terminated immediately without any prior notice.
15. Any damage caused to the mill due to interruption in work will be compensated by the contractor.
16. If the work is not done properly, the party can be fined.
17. The contractor will ensure that all his employees maintain peace and discipline in the factory premises and the company will have the right to check and search you and your employees at any time.
18. The contractor will ensure that any person engaged by him should not be minor or female.
19. If any difference of opinion arises during the course of work, the decision of the mill management shall prevail.
20. The work will be done as per the order of the person appointed by the mill management.
21. The quality & workmanship of the jobs shall conform to the pattern and standard prescribed by the power plant Head.
22. Working hours for contracted jobs will be including Holidays and Sundays or as decided by the Management from time to time.
23. The contractor will submit the list of workers engaged by him for the jobs allotted at Security Gate of the Mills duly verified by power plant Head. The list must contain name, father's name, permanent address and age of workers.
24. Mill will provide electricity and water for the execution of work.
25. The contractor is not allowed to give sub contract to third party / factory worker.
26. The contractor will follow all laws of land.
27. The contractor will engage his own skilled and un-skilled labor for the said jobs.
28. The bills will be checked from an independent bill checker for the quality of work done.
29. If any accommodation will be available in the factory then it will be provided to you and in case of non availability of accommodation, you will make your own arrangement.
30. The contractor will ensure compliance of labor laws. There will be no relationship of master and servant between the company and persons engaged by the contractor.

31. The contractor will provide safety items to his labour & for any accident if occurs during the allotted job the Contractor shall be responsible for that.
32. The Mill will not be responsible to pay any compensation for any accident or mishap, which may occur during the execution of the contractual jobs.
33. Required insurance covers for your workman and machinery shall be arranged by you as per Law on your own risk and responsibility.
34. The contractor shall get registration under the contract labour (Regulation & Abolition) Act, 1970.
35. All statutory liabilities or your employees will be paid by contractor such as workman compensation, P. F. etc. and you will cover your personnel for accident and death whilst performing the duty. Our concern will not be liable in any way.
36. The contractor should be registered with P.F. Department or have applied for registration.
37. The contractor will make compliance of the provisions of Labor Laws, viz, Minimum Wages Act, ESI, PFF Acts, Contract Labor Act etc., if any violation is found on your part, you will be held responsible.

- **The bidders shall submit the required eligibility documents in the PQQ Bid having following documents.**

**Information /documents to be attached by the tenderers with the PQQ Bid where ever is applicable.**

- 1) Copy of latest three year purchase / work order of firms / companies for the same type of materials /Jobs.
- 2) Certificate from the proprietor/partner/firm authorizing firm's representative to sign/participate in opening and negotiation of the tender (signature duly attested).
- 3) Copy of Sales Tax/GST registration number.
- 4) Copy of PAN Card.
- 5) The information i.e. Firm/Company Name, Complete Address, Contact person, Mobile No. & e-mail ID to be attached.
- 6) EMD or RTGS/NEFT details.

**In case of Non-attachment of the above (wherever is applicable) the PQQ bid shall be rejected.**

### Commercial Terms & Conditions:-

- 1) Payment terms: -
  - a) For material supply: 30 days after receipt of material subjected to quality approved.
  - b) For job work: 30 days after submission of verified bills subjected to satisfactory completion of work.
- 2) Price will be at site (Naraingarh Sugar Mills Ltd).
- 3) SGST/CGST/UGST/IGST will be extra as applicable as per norms (Our GST No. 06AAACN0454G1ZV).
- 4) TDS to be deducted as per GST Rules (if applicable).
- 5) **It will be mandatory condition, that no employee/his family member / relative can take participate directly or indirectly in BID.**
- 6) Presence of BIDDER by self in case of proprietor/ Partner or Authorised person with authority letter in case of partnership/Co. is necessary at the time of opening of tender is must.
- 7) **Liquidated Damages:** Time is the essence of this supply of material / completion of job. Hence, you shall strictly adhere to the delivery of material / completion of job. You are liable to pay liquidated damages towards late delivery of the material / completion of job decided by mill's management.
- 8) If at all L-1 party refuses to undertake the job / supply then purchase committee shall have the right to award the order to second lowest party on the finalized rates in the interest of the Mills.

- 9) Board/Management of the Mills shall have the right to negotiate with other participants also if quoted rates of L-1, L-2 & L-3 party do not seem to be reasonable upto the marks in the interest of the Mills.
- 10) Board/Management of the Mills shall have the right to black-list the defaulter party from the Mills.
- 11) In the event of leaving the work in the middle, the work can be done by another party at the party's expense and the bill will be deducted from the payment of party.
- 12) The quoted rate will be valid for the whole crushing season, 2024-25.
- 13) Rates are to be quoted on the basis of above said terms & conditions.
- 14) Conditional tender will not be accepted.
- 15) Successful bidder will have to submit the certificate on firm letter pad/Invoice bearing the below mentioned contents :-

“Certified that the rates quoted in this tender are the lowest possible. And if it comes out that perchance, we had quoted/were to quote lower basic rates in any Sugar Mill/organization during the currency of contract/order; we shall intimate the same and refund the difference of value immediately within fifteen days. If we fail to do so and your mills come to know of it through own other sources, then your mills shall be entitled to claim the amount of double the difference of the cost from us”.
- 16) The undersigned reserves the right to accept or reject any or all the tenders without assigning any reason.
