- **Earnest Money:** The Purchaser will deposit the earnest money amounting to Rs. 1,00,000/- by demand draft with the tender. The tender will not be accepted without earnest money.
- The purchaser will have to be deposited amounting to Rs. 5,00,000/- as security within two days after the date of issue of order and before loading the scrap into vehicle. The security will be forfeited if the purchaser fails to purchase / lift all type of scrap.
- The rates will be remained same for the quantity of 1st ordered as mentioned above and shall not be revised in any condition.
- The above rates are exclusive of all taxes and levies.
- The purchaser has to make his own arrangement of transport at his own responsibility and cost.
- The purchaser has to deposit total amount against the quantity of scrap purchased on that day after the weighment and before leaving the mills campus by getting prescribed gate pass.
- Scrutiny and cutting of scrap including the cost of gas is in the scope of purchaser, however gas may be issued from mills store and the cost will be charged/ debited.
- You will be fully responsible for any accident occurring during the ordered job.
- That in case of any dispute, the opinion of the management will be final and binding for the purchaser.
- If the work of purchaser is not satisfactory, the order is liable to be terminated immediately without any prior notice
- The contractor will ensure compliance of labor laws. There will be no relationship of master and servant between the company and persons by the purchaser.
- All statutory liabilities of employees of purchaser will be paid by him such as workman compensation, P.F. etc. and he will cover his personnel for accident and death whilst performing the duty. Our concern will not be liable in any way.
- The purchaser will ensure that person engaged by him should not be minor or female.
- The company has the right to terminate this order at any time without any notice or assigning any reason.
