#### Terms & Conditions for contractual jobs:-

1. **Security Money:** - The contractor should have to deposit Security of Amount Rs. 0.5 Lac within three days of the receipt of order which will be refunded after satisfactory completion of contract. No interest will be paid on this amount.
2. The contractor should have to provide sufficient number of Labour to removal the entire binding material of the cane from cane carrier.
3. The Binding material will be lifted immediately by own means.
4. The timing of removal of binding material for only mills workers will be in the morning and evening for one hour each.
5. Income tax and provident fund etc shall be deducted as per rule applicable and the contractor should have EPF number from Govt. Deptt. The Service tax, if any will be in the scope of the contractor. The Mills have no responsibilities for non compliance of any legal formalities and responsibilities for the contractor labour. The Contractor shall give an affidavit of Rs. 20/- regarding compliance of all the legal formalities regarding his labour.
6. The contractor should have to take all the safety measures for labour while the work is in progress and the Mills shall not be responsible for any accident/mis-happening to labour.
7. In case contractor fails to do the above job to the satisfaction of the Management, it shall be at liberty to make other alternative arrangement at contractor's risk and cost without giving any notice and security amount shall be forfeited.
8. In case of any dispute between the parties of agreement, the matter shall be referred to the Deputy Commissioner Ambala for Arbitration and the decision of the Arbitrator shall be binding on both the parties.
